
Please be informed that the Senate Committee on Foreign Relations will conduct its fourth public hearing on **June 4, 2025, Wednesday, 10:00 a.m., at the Senator J.P. Laurel Room, 2nd Floor, Senate of the Philippines, Pasay City**, to continue the discussion on the following:

1. Clarification of the involvement and the roles of the International Criminal Court, the International Criminal Police Organization, and the various government agencies in the arrest of Former President Rodrigo Roa Duterte (FPRRD);
2. Confirmation that measures were taken to ensure that the rights of FPRRD under domestic laws and relevant treaties were properly protected throughout the process; and
