Please be informed that the Public Hearing of the Committee on Health and Demography, joint with the Committee on Finance, scheduled on Thursday, January 16, 2025, starting at 10:30 a.m. at the Senator Laurel Room, 2/F Senate of the Philippines, Pasay City, will include the continuation of discussions on the Lack of Anti-Venom Supplies and Trained Personnel in All Regional Hospitals.
