Please be informed that the **Committee on Public Services**, joint with the Committee on Local Government, will conduct its **Second Public Hearing** on **Monday, 13 January 2025, 10 a.m.**, at **Senator Recto Room, 2nd Floor, Senate of the Philippines, Pasay City**.

The Committee will continue its discussion on the following:

1. **SBN 1465** - AN ACT ALLOWING AND REGULATING THE USE OF MOTORCYCLES AS PUBLIC UTILITY VEHICLES, AMENDING FOR THIS PURPOSE REPUBLIC ACT NO. 4136, OTHERWISE KNOWN AS THE LAND TRANSPORTATION AND TRAFFIC CODE, AND FOR OTHER PURPOSES (*Introduced by Senator Ramon Bong Revilla Jr.*);
2. **SBN 1328** - AN ACT RECOGNIZING MOTORCYCLES AS PUBLIC UTILITY VEHICLES, AMENDING FOR THIS PURPOSE REPUBLIC ACT NO. 4136, OTHERWISE KNOWN AS THE LAND TRANSPORTATION AND TRAFFIC CODE AND REPUBLIC ACT NO. 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE, AS AMENDED, AND FOR OTHER PURPOSES (*Introduced by Senator Imee R. Marcos*);
3. **SBN 1004** - AN ACT ALLOWING AND REGULATING THE USE OF MOTORCYCLES AS PUBLIC UTILITY VEHICLES, AMENDING FOR THIS PURPOSE REPUBLIC ACT NO. 4136, OTHERWISE KNOWN AS THE LAND TRANSPORTATION AND TRAFFIC CODE, AND FOR OTHER PURPOSES (*Introduced by Senator Sonny Angara*);
4. **SBN 819** - AN ACT ESTABLISHING THE RIGHTS OF PASSENGERS OF TAXIS, TOURIST CAR TRANSPORT SERVICES AND OTHER SIMILAR VEHICLES FOR HIRE (*Introduced by Senator Win Gatchalian*);
5. **SBN 167** - AN ACT ALLOWING THE USE OF MOTORCYCLES AS PUBLIC UTILITY VEHICLES, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 4136, OTHERWISE KNOWN AS THE LAND TRANSPORTATION AND TRAFFIC CODE, AND FOR OTHER PURPOSES (*Introduced by Senator Joseph Victor G. Ejercito*);
6. **SBN 104** - AN ACT ALLOWING AND REGULATING THE USE OF MOTORCYCLES AS PUBLIC UTILITY VEHICLES, AMENDING FOR THIS PURPOSE REPUBLIC ACT NO. 4136, OTHERWISE KNOWN AS THE LAND TRANSPORTATION AND TRAFFIC CODE, AND FOR OTHER PURPOSES (*Introduced by Senator Grace Poe*);
7. **PSRN 1252** - RESOLUTION DIRECTING THE APPROPRIATE COMMITTEE TO CONDUCT AN INQUIRY IN AID OF LEGISLATION, TO ADDRESS THE SURGE PRICING AND PASSENGER/CLIENT COMPLAINTS AGAINST TRANSPORTATION NETWORK COMPANIES (TNCs) WITH THE END IN VIEW OF STRENGTHENING THE REGULATION OF TNCs, PARTICULARLY THE TRANSPORTATION NETWORK VEHICLES SERVICE (TNVS) (*Introduced by Senator Raffy T. Tulfo*);
8. **PSRN 1251** - RESOLUTION CALLING FOR AN INVESTIGATION, IN AID OF LEGISLATION, ON THE METROPOLITAN MANILA DEVELOPMENT AUTHORITY'S (MMDA) PROHIBITION OF MALL-WIDE SALES IN THE NATIONAL CAPITAL REGION DURING THE HOLIDAY SEASON, TO DETERMINE WHETHER THE POLICY

CURTAILS COMMERCE AND WHETHER IT IS EFFECTIVE IN ADDRESSING TRAFFIC CONGESTION *(Introduced by Senator Raffy T. Tulfo);*

9. **PSRN 872** - A RESOLUTION DIRECTING THE APPROPRIATE SENATE COMMITTEE TO CONDUCT AN INQUIRY IN AID OF LEGISLATION ON THE REGULATION OF TRANSPORTATION NETWORK VEHICLE SERVICES (TNVS) AND OTHER COMMON CARRIERS *(Introduced by Senator Raffy T. Tulfo);* and
10. **PSRN 319** - RESOLUTION INQUIRING, IN AID OF LEGISLATION, AS TO THE CURRENT STATUS OF THE TRAFFIC MANAGEMENT PLAN IN THE PHILIPPINES PENDING THE END OF COVID-19 PANDEMIC *(Introduced by Senator Mark A. Villar).*
