- **Senate Bill No. 364-** AN ACT INSTITUTIONALIZING THE LIFELONG LEARNING DEVELOPMENT FRAMEWORK, BROADENING THE MANDATE OF THE PHILIPPINE QUALIFICATIONS FRAMEWORK - NATIONAL COORDINATING COUNCIL (PQF-NCC), AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 10968, OTHERWISE KNOWN AS THE PHILIPPINE QUALIFICATIONS FRAMEWORK ACT, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES by Sen.
