1. **SBN-2885** – AN ACT STRENGTHENING THE PHILIPPINE CIVIL REGISTRATION AND VITAL STATISTICS SYSTEM, REPEALING FOR THE PURPOSE ACT NO. 3753 OR THE LAW ON REGISTRY OF CIVIL STATUS, PROVIDING FUNDS THEREFOR, AND FOR OTHER PURPOSES (*Introduced by Senator Jinggoy E. Estrada*); and
2. **SBN-371** – AN ACT PROVIDING FOR A COMPREHENSIVE AND RESPONSIVE CIVIL REGISTRATION AND VITAL STATISTICS SYSTEM, PROVIDING FUNDS THEREOF, AND FOR OTHER PURPOSES (*Introduced by Senator Risa Hontiveros*).
