## INVITATION TO BID FOR

## "HOSPITALIZATION BENEFIT FOR SENATE EMPLOYEES FROM JANUARY TO DECEMBER 31, 2025"

- 1. The Senate of the Philippines (Senate), through the National Expenditure Program/General Appropriations Act or Special Appropriations of 2025 intends to apply the sum of the ABC to payments under the contract for Project Identification No. 24-10-803. 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4. Prospective Bidders may obtain further information from the Senate Bids and Awards Committee (BAC) Secretariat through the contact details given below and inspect the Bidding Documents as posted in the Senate website and the Philippine Government Electronic Procurement System (PHILGEPS) website.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders by sending a request through the Bids and Awards Committee electronic mail address at <a href="mailto:bac@senate.gov.ph">bac@senate.gov.ph</a> during Senate office hours on or before the deadline of availability of bidding documents. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.
- 6. The **Senate** will hold a Pre-Bid Conference **as scheduled** at **the given address above** which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before *the deadline for submission of bids*. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

Bid opening shall be as scheduled at the given address above. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

Bidders who submitted their bidding documents, bid proposal and paid the non-refundable fee may attend the opening of bids physically.

- 9. In case two or more bidders have identical lowest complying or highest rated bids and have been post-qualified as the LCRBs or HRRBs, the Senate Bids and Awards Committee shall adopt the tie breaking method of "toss coin" for two (2) bidders post qualified as LCRBs or HRRBs or "draw lots" for three (3) or more bidders post qualified as LCRBs or HRRBs as the case may be, in accordance with Appendix 11 entitled GPPB Circular 06-2005 Tie Breaking Method of the Revised Implementing Rules and Regulations of Republic Act No. 9184.
- 10. The **Senate** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
