RESOLUTION No. 132

RESOLUTION EXPRESSING THE SINCERE APPRECIATION OF THE SENATE TO ITS PRESIDENT, THE HONORABLE FRANKLIN M. DRILON, FOR HIS EXEMPLARY LEADERSHIP DURING THE SIXTEENTH CONGRESS

WHEREAS, Senate President Franklin M. Drilon, who was elected for the fourth time to lead the Senate in the 16th Congress, demonstrated great zeal, dedication and fairness in discharging his duties and responsibilities as leader of the institution;

WHEREAS, it was under his leadership that the Philippine Senate received the highest public approval rating among government institutions as shown in the survey conducted by the Pulse Asia;

WHEREAS, he also led the Senate in the enactment of political and judicial reform laws, such as the Sandiganbayan Reform Law which speeds up deliberation and hearings of the graft and corruption cases before its courts; the Amendment to the Probation Law of 1976, as amended, which expands the benefit of probation for more eligible convicts and provides for their rehabilitation; and the Sangguniang Kabataan Reform Law, the country's first law with anti-political dynasty provision;

WHEREAS, committed to uphold justice and good governance, he guided the Senate in conducting investigations, in aid of legislation, on the alleged graft and corruption in the government;

WHEREAS, his distinguished performance as the third highest official of the land, for having discharged his duties and responsibilities with expertise, wisdom and devotion to the national interest during the Sixteenth Congress, truly deserves commendation and recognition: Now, therefore, be it
