[REPUBLIC ACT NO. 12213]

AN ACT INCREASING THE BED CAPACITY OF THE SOUTHERN TAGALOG REGIONAL HOSPITAL IN THE CITY OF BACOR, PROVINCE OF CAVITE, FROM ONE HUNDRED (100) TO THREE HUNDRED (300) BEDS, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. The authorized bed capacity of the Southern Tagalog Regional Hospital in the City of Bacor, Province of Cavite, shall be increased from one hundred (100) to three hundred (300) beds.

SEC. 2. The existing professional healthcare services and facilities of the Southern Tagalog Regional Hospital shall also be upgraded to conform with and be commensurate to the increase in bed capacity as provided in Section 1 hereof.

SEC. 3. The existing workforce of the Southern Tagalog Regional Hospital, which includes doctors, nurses, and support personnel, shall be increased correspondingly.

SEC. 4. The Secretary of Health shall, after consultation with the Medical Center Chief of the Southern Tagalog Regional Hospital, and in coordination with the Secretary of Budget and Management and the Chairperson of the Civil Service Commission, determine the additional new positions to be created.


SEC. 5. The Secretary of Health shall immediately include in the Department's program the implementation of this Act, the funding of which shall be included in the annual General Appropriations Act.


SEC. 6. If any provision of this Act is declared unconstitutional, the remaining parts or provisions not affected shall remain in full force and effect.

SEC. 7. All laws, executive orders, issuances, and rules and regulations inconsistent with this Act are hereby repealed or modified accordingly.


SEC. 8. This Act shall take effect fifteen (15) days after its publication in the *Official Gazette* or in a newspaper of general circulation.


